
**Chesapeake Energy
Corporation Announces
Private Offering of Senior
Notes**

Chesapeake Energy Corporation today announced that it is commencing a private placement offering to eligible purchasers of \$600 million of a new issue of senior notes due 2015. The notes are expected to be eligible for resale under Rule 144A. The private offering, which is subject to market and other conditions, will be made within the United States only to qualified institutional buyers, and outside the United States only to non-U.S. investors under regulation S of the Securities Act of 1933.

Chesapeake intends to use the net proceeds to fund its recently announced tender offer for all of its approximately \$210 million outstanding 8.375% Senior Notes due 2008, to fund the recently announced acquisition of certain natural gas properties from Hallwood Energy Corporation, and to repay debt under its revolving bank credit facility. Remaining net proceeds from the offering will be used for general corporate purposes, including to fund costs of our drilling program and possible future acquisitions.

The new notes have not been registered under the Securities Act of 1933 or applicable state securities laws, and may not be offered or sold in the United States absent registration or an applicable exemption from the registration requirements of the Securities Act and applicable state laws. This announcement shall not constitute an offer to sell or a solicitation of an offer to buy the new notes.
