
**Chesapeake Energy
Corporation Announces Final
Results of 5.00% Cumulative
Convertible Preferred Stock

Chesapeake Energy Corporation today announced the final results of its previously announced offer to exchange 6.1847 shares of its common stock for each outstanding share of its 5.00% Cumulative Convertible Preferred Stock (Series 2003) (NYSE: CHKPrB, the "Preferred Stock") (CUSIP No. 165167800). The exchange offer expired at 5:00 p.m. New York City Time on Thursday, June 1, 2006.

Chesapeake issued 4,972,786 shares of its common stock in exchange for 804,048 shares, or 95.4%, of its outstanding 5.00% Cumulative Convertible Preferred Stock (Series 2003) tendered in the exchange offer. 38,625 shares of the Preferred Stock remained outstanding at the expiration of the exchange offer.
