

**Chesapeake Energy  
Corporation Announces  
Pricing of 6.25% Mandatory  
Convertible Preferred Stock  
Offering**

Chesapeake Energy Corporation today announced that it has priced its previously announced public offering of \$500 million of a series of 6.25% mandatory convertible preferred stock with a liquidation preference of \$250 per share. Chesapeake has also granted the underwriters a 30-day option to purchase a maximum of \$75 million in additional shares of mandatory convertible preferred stock. Chesapeake expects the issuance and delivery of the shares to occur on June 30, 2006, subject to customary closing conditions.

The annual dividend on each share of preferred stock is \$15.625 and is payable quarterly when, as and if declared by the company, in cash, common stock or a combination thereof, in arrears to holders of record as of the first day of the payment month, each March 15, June 15, September 15 and December 15 commencing September 15, 2006. The preferred stock is not redeemable.

The mandatory convertible preferred stock has a threshold appreciation price of \$34.86 which is 20% above the closing price of the common stock on June 27, 2006. Each share will automatically convert on June 15, 2009, subject to certain adjustments, into no fewer than 7.1715 shares of Chesapeake's common stock and no more than 8.6059 shares of Chesapeake's common stock, depending on the then-prevailing market price of Chesapeake's common stock. At any time prior to June 15, 2009, the preferred stock may be converted at the option of the holders or, under certain circumstances, by Chesapeake.

Chesapeake intends to use the net proceeds from the offering, together with proceeds from concurrent public offerings of senior notes and common stock, to fund its recently announced Barnett Shale acquisitions for \$932 million, to repay outstanding indebtedness under its revolving credit facility and for general corporate purposes.

The offering is being made under a shelf registration statement that became effective on December 8, 2005.

Goldman, Sachs & Co., Banc of America Securities LLC, Credit Suisse, Lehman Brothers Inc. and UBS Securities LLC are acting as joint book-running managers for the offering.
